## 1) Buy-and-Build Platform Integration Assessments

- Standardized playbook; rapid complexity scoring; 100-day plan per add-on.

## 2) Carve-Out & Separation Assessments

### **Entry — Separation Feasibility Checkpoint (≈10 days; \$65,000)**

- Dependency mapping; preliminary complexity, ROM cost/timeline; exec go/no-go.

### **Core — Separation Architecture & Budget (≈4 weeks; \$105,000-\$155,000)**

- What stays/goes/new; verified OTC + standalone OpEx; 100-day mobilization.
- IC summary with escrows/indemnities guidance; proven large-scale execution.

### **Expansion — Separation Program Implementation (12-24 months; \$200,000-\$400,000)**

- Fractional leadership; weekly reporting; TSA exit planning; vendor negotiations.

## 3) SaaS & Subscription Retention Analytics

### **Entry — Retention Health Check (≈1 week; \$10,000)**

- Subset Markov analysis; mini-report vs claimed retention; scenario impact; creditable.

### **Core — Retention Analytics & Forecast (≈4-6 weeks; \$35,000-\$65,000)**

- Transition matrices, 3-year projections; valuation sensitivity; NRR actions.

### **Expansion — Improvement & Monitoring (12-week sprint; ~\$5,000/mo monitoring)**

- Pilot CS enhancements; monthly dashboard; quarterly refresh; standing advisory.

## 4) 100-Day Value Creation Sprints

### **Entry — Workshop (2 hours; Free) or 1-Week Diagnostic (~\$10,000)**

- Workshop memo with 3-5 initiatives; or quick function diagnostic with quick wins.

### **Core — 100-Day Sprint (≈12-14 weeks; \$45,000-\$75,000)**

- Baseline → execution → Impact Report; Implementation Playbook; weekly cadence.

### **Expansion — Retainer & Multi-Company Programs (scope-based)**

- On-call CTO/advisory; themed waves across portcos (cyber, cloud, etc.).

### 5) AI Governance & Risk Assessments

Entry — AI Risk Awareness Workshop (1–2 hours; Free–\$5,000)

- AI Governance 101; inventory & risk heatmap; one-page summary

Core — AI Governance Diligence & Gap Analysis (≈4–6 weeks; \$55,000–\$85,000)

- Model inventory/docs; compliance; bias testing; security; quantified risk; roadmap.

Expansion — Board Advisory & Implementation (3–6 months; ongoing)

- Policies, testing, monitoring; quarterly audits; board assurance.
